\*Any Vendor selling food is responsible for obtaining a Food License (Permit) issued by the East Longmeadow Health Department. An application for this license can be found on the District's website <u>here</u>. The application must be submitted a minimum of two weeks prior to the event. The License will be issued the day of the event following an onsite inspection.

- 1. The market is located at Center Field Maple Street/Shaker Road
- 2. This event will take place rain or shine. <u>Cancellation will only occur in the event of thunder/lightning.</u>
- 3. Vendors should set up between 12:30 p.m. 1:30 p.m. on dates participating between May October 2021.
