Vendors must provide their own tents, tables, chairs & signs. Health department farmers market application fee is \$75.00 for the season. Please make two checks out, both made payable to the Town of East Longmeadow. One for total for the booth fee, and one for the \$75.00 farmers market application fee. If you are interested in doing one market, please make a \$45.00 check payable to the Town of East Longmeadow for a 1 day temporary food permit.
